Party nomination of candidate for election is finalized by holding primary election among voter and member of party in each constituency, as soon as elections are announced by government. Fee for a voter is Rs.1200/- per year. For ordinary member it is Rs.1200/- per year. If he/she wants to contest election then he/she must become active member fee for active member is Rs.100,000/- Active member must make at least 10 voter or member in each polling booth of his constituency. Then only Active member is allowed to offer him/herself for nomination from his her constituency for election conducted by election commission. Fee can be paid in cash/cheque/DD/pay order.
